POLICY RELATED WORK

Over the past month, MAIT has been deeply engaged in identifying and addressing the challenges encountered by the IT, telecom, and electronics hardware industry, actively liaising with appropriate government departments for resolution. Amidst a multitude of initiatives undertaken during this period, the association has prioritized several key issues, which are outlined below:

Department of Consumer Affairs (DoCA)

MAIT submitted a representation to Ms. Nidhi Khare, Secretary, Department of Consumer Affairs on 15 April '24. In the representation, MAIT requested DoCA to grant QR Code related exemptions under the Legal Metrology (Packaged Commodities) (Amendment) Rules, 2023.

Ministry of Corporate Affairs(MCA)

On 04 April 2024, MAIT filed a representation to Dr. Manoj Govil, Secretary, MCA, requesting extension of deadline for submission of comments on Draft Digital Competition Report 2024 and Draft Bill on Digital Competition Bill.

Department for Promotion of Industry and Internal Trade (DPIIT)

MAIT submitted its inputs with DPIIT regarding Jan Vishwas 2.0 on 15 April '24.

Directorate General, Systems & Data Management

On 19 April '24, MAIT filed a representation to Shri Yogendra Garg, Directorate General, Systems & Data Management (in charge of ICEGATE) regarding customs duty payment issues (via NEFT) in ICEGATE Portal.

Directorate General of Foreign Trade (DGFT)

MAIT submitted a representation with Shri Nitish Suri, Joint DGFT on 25 April '24, requesting reforms in end-user reporting requirement under India's export control regulation.

Central Pollution Control Board (CPCB)

MAIT representatives had a meeting with Shri Anupam Prakash, Jt. Secretary, CBIC on 26 April '24 to discuss Customs issues regarding HSN classification of Interactive Flat Panel Display (IFPDs).

Telecommunication Engineering Centre (TEC)
