May 2024 was a landmark period in MAIT's history, marked by significant developments in internal institution building and initiating important interactions with policymakers.

On May 21, 2024, a high-level delegation from MAIT met with the Hon'ble Secretary of MeitY to present its recommendations for the development of the Indian ICT industry. These recommendations emphasised the importance of introducing PLIs for components, wearables, and hearables to improve ease of doing business. The recommendations included suggestive measures for various key ministries, including the PMO. MAIT anticipates a series of meetings with these ministries in the coming days.

The measures identified by MAIT aim to make India self-reliant in electronics manufacturing, reducing dependency on other countries.

Meanwhile, MAIT is deeply engaged in the election process for its Governing Council Members and key officials, with results to be announced in the last week of June 2024.

In its efforts to transform the industry, MAIT has also initiated internal changes to provide better services. Under the guidance of industry leaders, MAIT successfully launched a new website featuring interactive elements and resources for its members. Additionally, I'm pleased to inform readers that the MAIT office has undergone a makeover, including an extension that provides additional space for staff and meetings.

## POLICY RELATED WORK

During the past month, MAIT has been actively addressing the challenges faced by the electronics industry. The association has engaged extensively with relevant government departments to seek resolutions. While MAIT has initiated numerous efforts during this period, some of the key issues addressed include:

#### Ministry of Electronics and Information Technology (MeitY)

- MAIT filed a representation filed to Shri Sushil Pal, Jt. Secretary, Ministry of Electronics & IT on 09 May 24, requesting intervention for Recommending Classification of IFPD under CTH 8741 to CBIC.
- On 22 May 24, MAIT filed another representation to Shri Sushil Pal, Joint Secretary, MeitY, requesting the latter to recommend the 'classification of IFPD' under CTH 84.

#### Department of Telecommunications (DoT)

- On 17 May 24, MAIT submitted industry Inputs to DoT regarding SAR Value norms for mobile handsets.






