#### POLICY RELATED WORK $\mathcal{S}$

During the last fortnight MAIT was deeply engaged in getting to know problems being faced by the electronics Industry and taking these up with the appropriate Government departments for resolution. While MAIT has undertaken a large number of initiatives during this period, some of the key issues that were taken up by the association are listed below:

#### Ministry of Electronics & Information Technology (MeitY)

- MAIT submitted its comments on CCTV testing to MeitY on 08 August 2024.
- MAIT filed a representation to Shri Sushil Pal, Jt. Secretary, Ministry of Electronics & IT on 22
  August 2024, requesting urgent intervention for the "Clearance of Interactive Flat Panel
  Display (IFPD) Parts under HSN 8473 Shipment at Mumbai and Chennai Ports".

#### Ministry of Environment, Forest & Climate and Change (MoEF&CC)

 MAIT filed a representation to Shri Naresh Pal Gangwar, Additional Secretary, Ministry of Environment, Forest and Climate Change on 01 August 2024, requesting to Delink EPR Credit and Environmental Compensation (EC) Pricing and extend the timeline for input on Electronic Trading and Settlement Platform for Plastic Packaging.

Secretary, MeitY.






## MAIT brainstorming session on "R&D and IP Initiatives for the Telecom Electronics Ecosystem

MAIT, along with other members of SAC, will compile the inputs from all stakeholders and present the industry's perspective to the government in the near future.








#### MAIT E-Waste Awareness campaign in collaboration with UNICEF and Bajaj **Foundation**








#### First Session in MAIT's MSME Success Strategies Series
