MAIT effectively conveyed industry concerns on several fronts:

- 1. Movement of Used IT Assets: We addressed the challenge of moving used IT assets from special economic zones to domestic tariff areas.
- 2. End-User KYC Process: We advocated for exemptions in the end-user KYC process, specifically for procuring new SIM cards for research and development purposes.
- 3. E-Waste Management: Our discussions included issues related to EWMR (Extended Producer Responsibility for E-Waste Management), BWMR (Bulk Waste Management Rules), and PWMR (Plastic Waste Management Rules).

Additionally, the Interim Union Budget 2024-25 brought positive news. MAIT appreciates the increased budget allocation for the Production-Linked Incentive (PLI) scheme under MeitY, which has been raised from ₹4,650 crore to ₹6,200 crore. This allocation underscores the government's commitment to promoting the ICT hardware and electronics manufacturing sector as a strategic focus area.

In collaboration with Deloitte, a leading consulting organization, MAIT conducted a comprehensive knowledge session on the budget. We analysed its implications for the ICT sector in detail, ensuring that our members stay informed and prepared.

During the last month, MAIT has been actively involved in understanding the challenges faced by the Electronics Industry and addressing them with the relevant Government departments for resolution. While undertaking numerous initiatives during this period, some of the key issues addressed by the association are outlined below:

Department of Commerce (DoC)

D2M Workshop organised by TEC



MAIT actively participated in D2M (Direct to Mobile) Workshop organised by TEC (Telecom Engineering Centre) on 21 February 2024. The Workshop was chaired by Ms Tripti Saxena, Sr DDG, TEC. The Workshop was attended by various stakeholders like Prasar Bharti, Qualcomm, Saankhya labs, mobile brands, industry associations, thinktanks and academia. It mainly revolved around the broadcasting technologies and their related standards like ATSC 3.0 and 3GPP 5G Multicast Broadcast/Multiple service, etc.

TEC has released a draft report on "Direct Broadcasting to Mobile Handheld devices (D2M)" in this regard. At this platform, MAIT highlighted the challenges faced by the industry in the implementation of D2M. MAIT recommended that the adoption of any technology should be left to the market forces and there should not be any compulsory mandates on technology and its corresponding standard.
